Safeguarding & Prevention Policy

1. Definition of Safeguarding

2. Responsibilities

- The designated safeguarding officer will assess the situation, initiate any necessary actions, and follow the appropriate reporting procedures in accordance with legal and regulatory requirements.

We are committed to open and transparent communication with participants, parents/guardians (if applicable), and relevant authorities in cases of suspected harm or abuse.

8. Prevention Education

We will provide education and resources to our instructors, staff, and participants about safeguarding measures, recognizing signs of potential harm, and how to report concerns.

9. Continuous Review

We will regularly review and update our safeguarding policies and procedures to ensure they are aligned with best practices and current legal requirements.
